I live at 4326 Mistflower Way Northlake Texas, 76226

I bought this property in 2021 in Canyon Falls due to the beauty of the community and somewhat rural feel that it holds. Our property is a corner lot that backs up to Cleveland Gibbs rd. on the back a farm on the left side. We enjoy our days watching cows and other wildlife on the surrounding farms and nights watching the sunset. After closing on the house, we made a large investment in a pool and outdoor kitchen that we use frequently.

These proposed transmission lines would ruin all of this; E8, F2 and F3 would directly impact our home as they would run not only along the left side of the property but also across the back property line and likely within 25 ft of our home. (I have included a copy of the map and highlighted the impacted areas.)

Our home is also our future as at some point we look to sell and move to a community that would suit us in our retirement years. The addition of transmission lines running throughout the property would cause the home value to drop between 30 – 50%; not insubstantial when you consider the high value, we paid for the home just two years ago.

I ask that the commission take into consideration the entirety of Canyon Falls and understand the impact it would have on the homeowners, wildlife, and overall beauty of the community.
