



2. I am familiar with BNSF's property impacted by the proposed transmission line proposed in the above captioned proceeding.

3. BNSF owns land located in the western portion of the study area for Oncor Electric Delivery Company's ("Oncor") Ramhorn Hill to Dunham 345 kV Transmission Line CCN proceeding filed with the Public Utility Commission of Texas.


4. BNSF's property would be crossed by multiple routing segments proposed by Oncor in the above-captioned docket, including Segments M1, M3, and M5.

5. Segments M1, M3, and M5 as proposed by Oncor in the above captioned proceeding would have a significant negative impact on BNSF future operations.


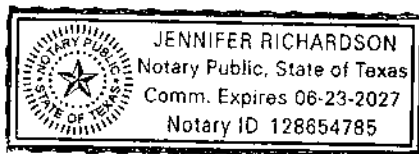
6. As a result, BNSF proposes segment modifications to Segments M1, M3, and M5 which would have a far less severe impact on BNSF.
