REPLY BRIEF OF JEREMY AND KATIE YOUNG

As Intervenors, we, Jeremy and Katie Young, timely file this reply brief on September 14, 2023, in support of the proposed alternatives of Route 179C La Estancia 1 or proposed alternative Route 179C La Estancia 1 & 2, which has been labeled as part of the best meets routes proposed by Oncor. This route meets the routing criteria and addresses the concerns by all Intervenors impacted in the eastern section. The intervenors that agreed to this route were Furst Ranch Intervenors, Oncor, La Estancia Investments, DHL Supply Chain, Hillwood Parties, Jeff True, Seth DeLeon, Deborah Dallas, and the Town of Northlake. As Intervenors, we request that the Public Utility Commission of Texas ("Commission") approve Route 179C La Estancia 1 or proposed alternative Route 179C La Estancia 1 & 2.

UNDERSTANDING OF POSITIONS FROM THE POST-HEARING BRIEFS

After review of the post-hearing briefs, the majority of parties that opposed Route 179, or any of the alternative routes, provided opposition to Link J3 specifically, but did not support an alternative route. In comparison, the parties that did support Route 179 also offered alternative routes for consideration. Two routes that were provided as alternatives were Route 179C La Estancia 1 and alternative Route 179C La Estancia 1 & 2, which have support from all parties from the eastern section. The 179C La Estancia Routes offer routes that run the perimeter of property boundaries and public roads, reduce the number of parks or recreational areas impacted from four to three¹, and are either tied or have the lowest cost alternatives from Oncor Exhibit 25.

CONCLUSION

Route 179C La Estancia Alt 1 or Route 179C La Estancia Alt 1 & 2 are clearly the routes that have support and offer the best meets route for consideration. As Intervenors, we request that the Commission approve Route 179C La Estancia Alternative Route 1 or La Estancia Alternative Route 1 & 2.
