I'm writing to comment on Docket No. 55067. My comments are in relation to potential routes C4, C5, C7, C8, C9, E5, E8, F3, F4, F8, G5, H6.

I own a home located near one or more of the utility's proposed routes for a transmission. The address is 3333 Meridian Drive, Northlake, TX 76226. There are additional "other" category circumstances I would like to mention here.

There are several factors causing frustration as a homeowner, a wife, a mother, and a grandmother. While it is an emotional subject, I will try to stick to the facts:

- Most importantly, my husband has had some serious medical conditions in his past that required surgery to implant a cardiac defibrillator.
- He cannot own one of the new iPhones due to the amount of EMF activity which is a big concern given the planned two 345 kV circuits and room for a third 138 kV circuit in the future.
- EMF activity is not only a health concern for my husband, but also myself, my children, and my
 grandchildren that spend time in our backyard and on the nature trails that are available through
 the conservation area.
- The amount of EMF activity would also impose a health concern to dozens of hikers, walkers, and bikers that daily utilize the trails where the transmission lines would be installed.
- This imposition would cause a negative impact on my property value.
- There is already a transmission line running through our neighborhood, so there is no
 reasonable expectation that would include a needed second line would pass through the same
 community.

I hope you understand my perspective and the facts presented. I'm protesting to ensure the pathway chosen doesn't include any of routes I have mentioned that are in proximity to my home.
