Protest comments for Joana Lynne Bird 604 Ridge View Way, Justin, TX 76247, resident Hardeman Estates.


I am greatly concerned about the impact that will be felt by the residents of the city of Justin. One route of the project will run right through the south side of Hardeman Estates wiping out 3 dozen homes just in the subdivision and an apartment complex off Hardeman Blvd. I can't even count the number of multi-family units on the south side of the line that would be affected. Any idea where the hundreds of people will go if their homes are destroyed by this project. The main reason for protesting the proposed routes of the lines to pass through any of the city of Justin is the general health of ALL resident, be that in the close vicinity of the lines or several blocks away. Justin is a city of many elderly longtime residents and new families who moved into the area because of the tranquility and quality of life in a small north Texas community. Putting an obvious health hazard in our back yards is not acceptable when there are acres of land with little to no housing structures and miles of openness to create better pathways for the lines.

The loss of all the trees along Trail Creek will greatly affect air quality, cause increase in noise, and destroy the natural habitat of many native plants and animals. The development of the Justin City Center will be affected and all the years of planning and preparing will have been in vain. There are two parks that are in jeopardy.

Property values of the property in close proximity will diminish to a level that is unsustainable.

I feel sorry for whomever ends up being affected by this project, but as the community of Justin we must believe the sheer number of structures and residents need to be taken into account when final decisions are made. Our money is as valuable as the money of ONCOR.
