HILLWOOD PARTIES' MOTION TO INTERVENE

Pursuant to the Public Utility Regulatory Act ("PURA"), Tex. Util. Code Ann. §§ 11.01 et seq., and 16 Tex. Admin. Code (TAC) §§ 22.102, 22.103(b)(2) and 22.104, Eagle Income Properties, LP, AIL Investment, L.P., Petrus Investment, L.P., HW Indian Springs, L.P., HWC Justin 407, LLC, HP Gibbs, LP, Pecan Square Phase 1, LLC, Pecan Square Phase 2A, LLC, Pecan Square Phase 2B, LLC, Pecan Square Phase 3A, LLC, and Pecan Square Phase 3B, LLC (each a "Hillwood Party," and collectively, the "Hillwood Parties") file this Motion to Intervene. In support, the Hillwood Parties respectfully show as follows:

I. BACKGROUND

On June 8, 2023, Oncor Electric Delivery Company LLC ("Oncor") filed an application to amend a Certificate of Convenience and Necessity for a proposed 345-kV transmission line in Denton and Wise Counties, Texas.

II. STANDING TO INTERVENE

Each Hillwood Party is a directly affected landowner who received notice from Oncor. Multiple proposed routes cross or otherwise directly affect the Hillwood Parties' property, as reflected in Oncor's application. Hillwood Parties own the following tracts identified by Oncor in its application as "Directly Affected Landowners": 803, 806, 807, 1106, 1107, 1108, 1110, 1270, 1271, 1272, 1273, 1273.1, 1275, 1287, 1288.1, 1326.01, 1326.02, 1326.03, 1326.04, 1330, 1331, 1331.01, 1332, 1351, 1352, 1356, 1357, 1358, 1503, 1891.

Accordingly, each of the Hillwood Parties have a justiciable interest in the outcome of this proceeding and, on that basis, seek to be admitted as intervenors. The interests of the Hillwood Parties are physically and legally different from any other party; thus, no other party can adequately represent their interests.
