I have personal knowledge of the facts contained herein, and they are true and correct to the best of my knowledge.
2. I am currently employed as Regulatory Manager II at Oncor Electric Delivery Company LLC ("Oncor"), and I am authorized to make this Affidavit on Oncor's behalf.
3. Pursuant to 16 Tex. Admin.
