RAMHORN HILL — DUNHAM 345 kV TRANSMISSION LINE PROJECT
Docket No. 55067

I am a property owner in Canyon Falls and object to the following proposed Oncor segments related to the RAMHORN HILL — DUNHAM 345 kV TRANSMISSION LINE PROJECT: C7, C8, C9, E3, E2 & E5. As a property owner, I own an undivided interest in the common areas associated with Canyon Falls.

A significant consideration in the purchase my home in Canyon Falls was directly related to the green belts and 14 miles of trails that are part of the community property owned by the members. Coming from the scenic Pacific Northwest, the natural, undisturbed green belts that support wildlife environment, drainage paths and trails, along with other community amenities were important to me. I paid a premium to purchase in Canyon Falls compared to other subdivisions that didn't have the same level of amenities.

The proposed Oncor segments that I referenced above will result in a direct economic, environmental and scenic loss to me and my community. The installation of those segments will have harmful and negative impacts on wildlife in the greenbelts. Preservation of environmental habitat is important not only to me and our community, but North, Texas as a whole as it continues to grow. These green belts are irreplaceable. Additionally, my home and the amenities of the community will experience a certain decrease in value as a result of those segments.

I encourage Oncor to choose the segments along 1171 instead of through Canyon Falls. 1171 is already a 6 lane road with existing powerlines. I appreciate that aesthetically, most people don't like the look of powerlines and supporting structures of this size. That said, placing them along corridors of other existing powerlines, minimizes their sprawl effect on additional properties and greenbelts.
