

We purchased our home in Canyon Falls along a greenbelt on the model home row for a significant premium. Since then, we have continued to add upgrades to our home. The 345 kV high voltage lines will directly and negatively impact the value of our home. We also regularly utilize the community amenities including, but not limited to hiking, biking, swimming, bird, and other wildlife watching, etc. among the walking paths, parks, and green belts in Canyon Falls. The proposed power lines significantly encroach not only on the views and desirability of these amenities, but also exert negative pressure on our local wildlife population and natural topography. For these environmental and economic reasons, we oppose C5, C7, C8, C9, C22, C23, E2, E3, E5, E8, and F2. Please either relocate this route south to the previously approved Army Corps route, which does not cross residential paths, or utilize the C3 – C6 – E6 pathway to avoid crossing our community and follow FM 1171 instead.
