#### COMMISSION STAFF'S REQUEST FOR EXTENSION

On June 16, 2023, the City of Pharr (Pharr) filed an application to amend its Certificate of Convenience and Necessity (CCN) No. 20643 in Hidalgo County under Texas Water Code (TWC) §§ 13.242 through 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 through 24.237. Pharr filed supplemental information on September 6 and 21, 202. Pharr filed supplemental information on September 6 and 21, 2023, and on December 18 and 21, 2023.

On January 25, 2024, the administrative law judge (ALJ) filed Order No. 7, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to provide final maps, certificates, and tariffs (if applicable) to the applicant for review and consent by February 5, 2024. Therefore, this pleading is timely filed.

## I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On January 31, 2024, Staff sent its first requests for information to Pharr. 16 TAC § 22.144 provides a deadline for responses from the parties to be within 20 days of filing a request for information. Twenty days from the filing of Staff's request for information is February 20, 2024. Staff will also require additional time to review the responses from the parties. Therefore, Staff respectfully requests that the deadline to provide final maps, certificates, and tariffs (if applicable) to the applicant for review and consent be extended until March 5, 2024.

#### II. CONCLUSION

Staff respectfully requests the entry of an order consistent with this pleading.
