**COMMISSION STAFF'S RESPONSE TO ORDER NO. 11 AND MOTION TO ADMIT
ADDITIONAL EVIDENCE**

On June 16, 2023, the City of Pharr (Pharr) filed an application to amend its Certificate of Convenience and Necessity (CCN) No. 20643 in Hidalgo County under Texas Water Code (TWC) §§ 13.242 through 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 through 24.237. Pharr filed supplemental information on September 6 and 21, 2023, December 18 and 21, 2023, February 9, 2024, and March 20, 2024.

On May 1, 2024, the administrative law judge (ALJ) filed Order No. 11, directing Staff (Staff) of the Public Utility Commission of Texas (Commission) to file the desired map and certificate and move for their admission into evidence by May 7, 2024. Therefore, this pleading is timely filed.

I. MOTION TO ADDITIONAL ADMIT EVIDENCE

Staff moves to admit the following additional evidence into the record of this proceeding:

1. The attached final maps and certificate provided by Staff to Pharr on March 4, 2024, and consented to by Pharr on March 11, 2024.

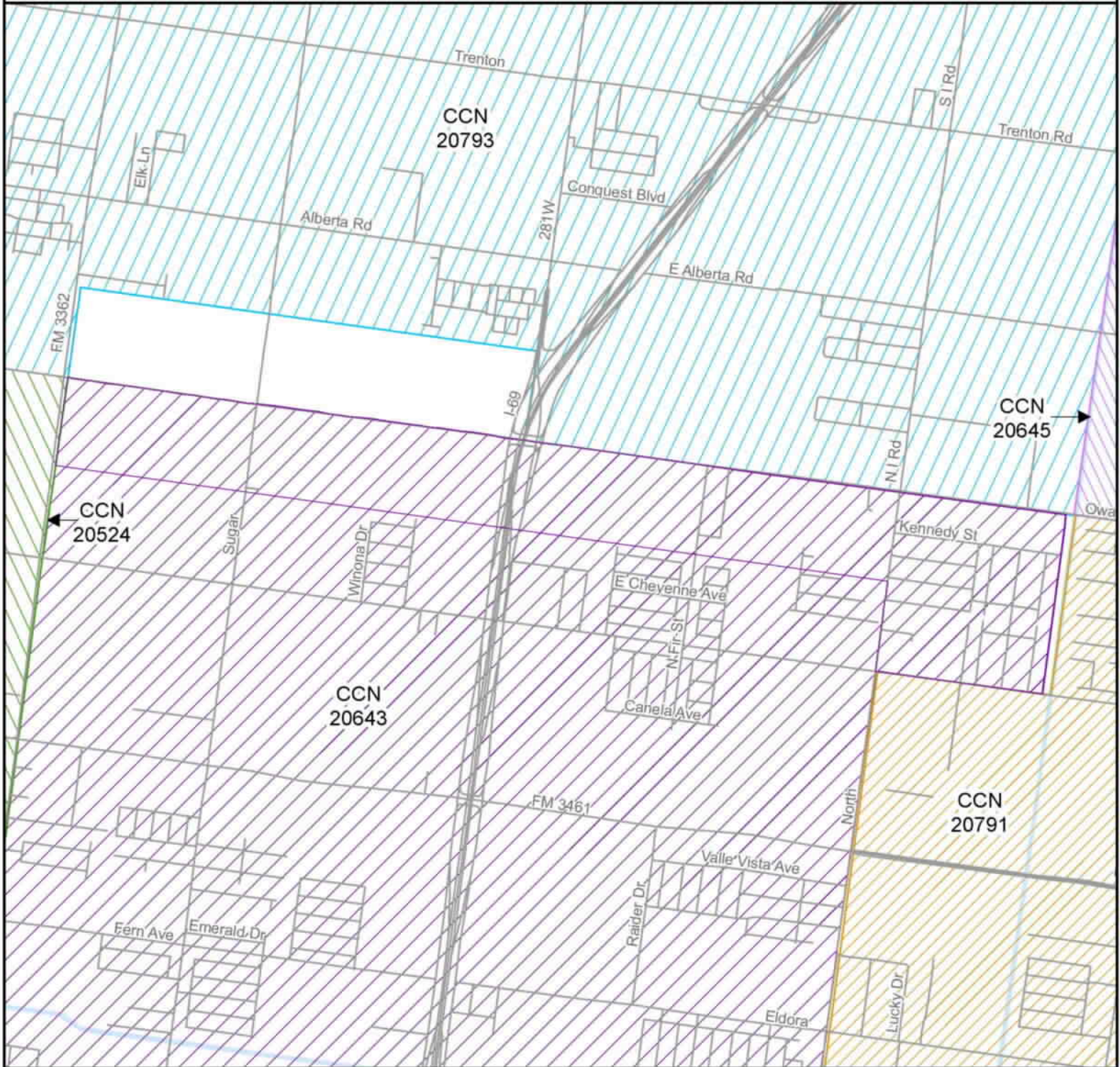
