## ERRATA SUMMARY TO THE DIRECT TESTIMONY AND EXHIBITS OF MARK E. GARRETT

On April 17, 2024, Cities Advocating Reasonable Deregulation (CARD) filed the Direct Testimony and Exhibits of Mr. Mark E. Garrett. After CARD filed Mr. Garrett's Direct Testimony, Mr. Garrett noticed there was an error in his interest calculations that needs to be addressed in an errata to his direct testimony.

Specifically, the interest calculation in Mr. Garrett's testimony as originally filed is significantly understated because the calculation does not include the cumulative interest on the refund balance. To correct this error, Mr. Garrett has prepared revised calculations in Exhibit MG-2 Errata and has flowed the corrected interest and refund amounts throughout his Errata Direct Testimony and Exhibits.
