COMMISSION STAFF’S UNOPPOSED REQUEST FOR EXTENSION

On June 30, 2023, CSWR-Texas Utility Operating Company, LLC and Wood Trails Water Supply, Inc. filed an application for approval of the sale, transfer, or merger of facilities and certificate rights Kerr County.

On July 5, 2023, the administrative law judge (ALJ) filed Order No. 1, establishing a deadline for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation regarding the administrative completeness of the application and proposed notice, along with a proposed procedural schedule by July 31, 2023. Therefore, this pleading is timely filed.

I. UNOPPOSED REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Staff is working with Applicants to resolve several mapping issues. Staff has conferred with Applicants and to allow enough time for Staff and the Applicants to resolve all issues and for Staff to review all maps once they are provided, Staff respectfully requests an extension of time of 14 days for Applicants to file revised mapping information and 30 days for Staff to review.

II. CONCLUSION

Staff respectfully requests the entry of an order consistent with the above request for extension.
