CSWR-TEXAS UTILITY OPERATING COMPANY LLC'S STATUS UPDATE ON AGENCY STANDING

The Administrative Law Judges filed orders in each of the above-referenced proceedings instructing CSWR-Texas Utility Operating Company, LLC ("CSWR-Texas") to file a response and affidavit attesting that it is in good standing with all applicable regulatory entities. As explained in the attached affidavit and pursuant to discussions with the Company's tax advisors, CSWR-Texas has filed and is current on all reports required by any governmental agency, including the Texas Commission on Environmental Quality, the Texas Comptroller of Public Accounts ("Comptroller"), and the Texas Secretary of State. Accordingly, to the best of the Company's knowledge, CSWR-Texas is in good standing with all applicable regulatory entities.

However, it appears that the records of one Texas agency, the Comptroller, incorrectly indicate that CSWR-Texas is not current on its franchise tax reports. The Company understands based on communications between its tax advisors and the Comptroller that the agency is presently updating its records to reflect that the Company did make this filing and is current on all necessary reports. The Company anticipates that it will make a filing this week in all applicable pending dockets to confirm that the Comptroller has updated its records to reflect the Company's status good standing.
