JOINT SUPPLEMENTAL MOTION TO ADMIT EVIDENCE AND PROPOSED NOTICE OF APPROVAL

COME NOW Wood Trails Water Supply, LLC ("Wood Trails") and CSWR-Texas Utility Operating Company, LLC ("CSWR-Texas"), together with the Staff of the Public Utility Commission of Texas ("Commission Staff") (collectively, "the Parties"), and file this Joint Motion to Admit Evidence and Proposed Notice of Approval. In support thereof, the Parties show the following:

I. <u>BACKGROUND</u>

On July 24, 2024, Wood Trails and CSWR-Texas (collectively, the "Applicants") filed closing documents reflecting the consummation of CSWR-Texas's acquisition of Wood Trails facilities and certificated area. Staff filed its recommendation on the sufficiency of closing documents on August 8, 2024, requesting that the application's closing documents be found sufficient. On August 21, 2024, the administrative law judge issued Order No. 15, granting an extension request and requiring the parties to jointly file a Proposed Notice of Approval by September 12, 2024. Therefore, this pleading is timely filed.

II. JOINT SUPPLEMENTAL MOTION TO ADMIT EVIDENCE

The Parties move to admit the following items into the record evidence of this proceeding:

- CSWR-Texas's Notice of Completed Transaction and Closing Documents, filed on July 24, 2024 (Interchange Item No. 46);
- Commission Staff's Recommendation on Sufficiency of Closing Documents and Proposed Procedural Schedule, filed on August 8, 2024 (Interchange Item No. 47); and
- Consent forms for CSWR-Texas and Wood Trails filed on September 3, 2024 (Interchange Item No. 51); and

4. The map, certificate, and tariff attached to the Joint Supplemental Motion to Admit Evidence filed on September 11, 2024.

III. PROPOSED NOTICE OF APPROVAL

CSWR-Texas and Commission Staff move for adoption of the attached Proposed Notice of Approval.

IV. CONCLUSION



NOTICE OF APPROVAL

This Notice of Approval addresses the application of Wood Trails Water Supply, Inc. (Wood Trails) and CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) (CSWR-Texas and Wood Trails collectively, the Applicants) for the sale, transfer, or merger of facilities in Kerr County. The Commission approves the sale, transfer, or merger of all of the facilities and service area held under Wood Trails' water certificate of convenience and necessity (CCN) number 11880 to CSWR-Texas, the cancellation of Wood Trails' water CCN number 11880, and the amendment of CSWR-Texas's water CCN number 13290 to include the area previously included in Wood Trails' water CCN number 11880.

I. Findings of Fact

The Commission makes the following findings of fact:

<u>Applicants</u>

- Wood Trails was a Texas corporation registered with the Texas secretary of state under file number 131915900.
- Wood Trails is an investor-owned utility that operates, maintains, and controls facilities for providing water service in Kerr County under CCN number 11880.
- Wood Trails owns and operates a public water system registered with the Texas Commission on Environmental Quality (TCEQ) as Wood Trail Water Supply public water system number 1330137.
- CSWR-Texas is a Texas limited liability company registered with the Texas secretary of state under file number 0803367893.
- 5. CSWR-Texas holds CCN number 13290, which obligates it to provide retail water service in its certificated service areas in multiple counties in Texas.

6. CSWR-Texas owns and operates multiple public water systems registered with the TCEQ.

<u>Application</u>

- 7. On June 30, 2023, Applicants filed the application at issue in the proceeding, partially under confidential seal.
- CSWR-Texas supplemented the application on August 16, 2023, September 12, 2023, and October 9, 2023.
- 9. In the application, Applicants seek approval of the following:
 - a. CSWR-Texas will acquire all of Wood Trails' water facilities and water service area under water CCN number 11880;
 - b. Wood Trails' water CCN number 11880 will be cancelled;
 - c. CSWR-Texas's water CCN number 13290 will be amended to include the area previously included in Wood Trails' water CCN number 11880; and
 - d. CSWR-Texas water CCN number 13290 will be amended to include 26.9 acres of uncertificated area.
- 10. The requested area comprises approximately 367.9 acres and includes the following:
 - a. 341 acres of singly certificated area under Wood Trails' CCN number 11880;
 - b. 26.9 acres of uncertified area adjacent to Wood Trails' existing certificated service area; and
 - c. 73 connections.
- 11. The requested area is located approximately 2.9 miles northeast of downtown Ingram, Texas, and is generally bounded on the north by Interstate Highway 10; on the east by Interstate Highway 10; on the south by the intersection of Farm to Market 1338 and Country Lane and on the west by Holloman Road.
- In Order No. 5 filed on October 31, 2023, the ALJ found the application, as supplemented, administratively complete.

<u>Notice</u>

- On November 17, 2023, CSWR-Texas filed the affidavit of Eric Rocchio, Regulatory Case Manager of CSWR-Texas, attesting that notice was provided to all current customers of Wood Trails, neighboring utilities, and affected parties on November 9, 2023.
- 14. On November 17, 2023, CSWR-Texas filed the affidavit of Mr. Rocchio attesting that there are no landowners owning tracts of land over 25 acres wholly or partially inside the requested area.
- 15. Also on November 17, 2023, CSWR-Texas filed the publisher's affidavit attesting to the publication of notice in the *Hill Country Community Journal*, a newspaper of general circulation in Kerr County, on November 8 and November 15, 2023.
- 16. In Order No. 7 filed on December 19, 2023, the ALJ found the notice sufficient.

Evidentiary Record

- 17. On February 1, 2024, the parties filed a joint motion to admit evidence.
- In Order No. 9 filed on March 4, 2024, the ALJ admitted the following evidence into the record:
 - a. the application, including confidential attachments, filed on June 30, 2023;
 - b. CSWR-Texas's first supplement to the application filed on August 16, 2023;
 - c. CSWR-Texas's second supplement to the application filed on September 12, 2023;
 - d. CSWR-Texas's third supplement to the application filed on October 9, 2023;
 - e. Commission Staff's recommendation on administrative completeness filed on October 26, 2023;
 - f. CSWR-Texas's affidavit of notice to current customers, neighboring utilities, and affected parties, including confidential Exhibit B, filed on November 17, 2023;
 - g. Commission Staff's recommendation on sufficiency of notice, filed on December 18, 2023;
 - h. Commission Staff's recommendation on the transaction, including confidential attachments, filed on January 19, 2024; and

- i. CSWR-Texas' status update and motion to admit evidence, including all attachments, filed on February 29, 2024.
- 19. On April 11, 2024, in Order No. 11, the ALJ admitted the confidential capital improvement plan and map.
- 20. On April 30, 2024, in Order No. 12, the ALJ admitted Staff's recommendation on the capital improvement plan and map.
- 21. In Order No. ___, filed on _____, the ALJ admitted the following additional evidence into the record:
 - a. CSWR-Texas's Notice of Completed Transaction and Closing Documents, filed on July 24, 2024;
 - b. Commission Staff's Recommendation on Sufficiency of Closing Documents and Proposed Procedural Schedule, filed on August 8, 2024;
 - c. Consent forms for CSWR-Texas and Wood Trails filed on September 3, 2024; and
 - d. The map, certificate, and tariff attached to the Joint Supplemental Motion to Admit Evidence filed on September 11, 2024.

<u>Sale</u>

- 22. In Order No. 10, filed on March 4, 2024, the ALJ approved the sale and transfer to proceed and required the applicants to file proof that the transaction had closed and that the customer deposits had been addressed.
- 23. On July 24, 2024, the applicants filed notice that the transaction was closed effective April 23, 2024, and confirmed that there were no outstanding customer deposits.
- 24. In Order No. 14 filed on August 9, 2024, the ALJ found the closing documentation sufficient.

CSWR-Texas's Compliance History

25. CSWR-Texas has not been under enforcement action by the Commission, Texas Health and Human Services, the Office of the Texas Attorney General, or the United States Environmental Protection Agency in the past five years for non-compliance with rules, orders, or state statutes.

- 26. The Commission's complaint records, which date back to 2017, show several complaints against CSWR-Texas, all but one of which have been resolved.
- 27. CSWR-Texas does not have a history of continuing mismanagement or misuse of revenues as a utility service provider.
- CSWR-Texas demonstrated a compliance history that is adequate for approval of the sale to proceed.

Adequacy of Existing Service

- 29. Currently, 73 water connections in the requested area are being served by Wood Trails through public water system number 1330137.
- 30. The Commission's complaint records, which date back five years, show two complaints against Wood Trails, both of which have been closed.
- 31. The last TCEQ compliance investigation of Wood Trails was on June 9, 2021.
- 32. Wood Trails does not have any violations listed in the TCEQ database.
- 33. CSWR-Texas stated that it intends to invest the capital required to make the upgrades, renovations, and repairs necessary to bring the systems into compliance with TCEQ regulations and to ensure customers receive safe and reliable service. CSWR-Texas stated that the needed improvements will begin when the systems are officially transferred to CSWR-Texas.
- 34. There is no evidence in the record that Wood Trails has failed to comply with any Commission or TCEQ order.

<u>Need for Additional Service</u>

- 35. There is a continuing need for service because Wood Trails is currently serving 73 connections in the requested area.
- 36. This is an application to transfer only existing facilities, customers, and an existing service area.
- 37. There have been no specific requests for additional service within the 367.9-acre requested area.

Effect of Approving the Transaction and Granting the Amendment

- 38. CSWR-Texas will be the sole certificated water utility for the requested area.
- CSWR-Texas will be required to provide continuous and adequate water service to current and future customers in the requested area.
- 40. Landowners in the requested area will have a water service provider available when they need to request water service.
- 41. All retail public utilities in the proximate area of the requested area were provided notice of the application and none filed protests, adverse comments, or sought to intervene in this proceeding.
- 42. Because this application is to transfer only existing facilities, customers, and service area, there will be no effect on any retail public utility providing service in the proximate area.
- 43. There will be no effect on landowners in the requested area because the requested area is currently certificated.

Ability to Serve: Managerial and Technical

- 44. CSWR-Texas owns and operates numerous public water systems registered with the TCEQ.
- 45. CSWR-Texas employs or contracts with TCEQ-licensed water operators who will operate the public water system being transferred.
- 46. CSWR-Texas stated that it intends to make upgrades, renovations, and repairs necessary to ensure that Wood Trails' public water system remains in compliance with TCEQ regulations and that customers receive safe and reliable service. The needed improvements will begin when the systems are officially transferred to CSWR-Texas. Once the water systems are compliant with TCEQ regulations, the service provided to the requested area will be adequate.
- 47. CSWR-Texas filed a capital improvement plan that included a budget and estimated timeline for construction of all facilities necessary to provide continuous and adequate service to the requested areas and was keyed to a map showing where such facilities will be located to provide service.

48. CSWR-Texas has the technical and managerial capability to provide adequate and continuous service to the requested area.

Ability to Serve: Financial Capability and Stability

- 49. CSWR, LLC, the immediate parent company of CSWR-Texas, is capable, available, and willing to cover temporary cash shortages, and has a debt-to-equity ratio of less than one. Therefore, CSWR-Texas satisfies the leverage test.
- 50. CSWR, LLC provided a written guarantee of coverage of temporary cash shortages and demonstrated that it has sufficient cash available to cover any projected operations and maintenance shortages in the first five years of operations after completion of the transaction and possesses the cash and leverage ability to pay for capital improvements and necessary equity investments. Therefore, CSWR-Texas satisfies the operations test.
- 51. CSWR-Texas's proposed capital improvements for Wood Trails' public water system exceed \$100,000.
- 52. Commission Staff requested a good-cause exception to the requirement that CSWR-Texas provide loan documentation for the amount it will need to make capital improvements to the system because CSWR-Texas does not obtain loans or purchasing for repairing systems. Additionally, CSWR-Texas states that it is already required to maintain a sufficient cash balance to purchase Wood Trails' water system and make capital improvements.
- 53. CSWR-Texas provided a firm capital commitment demonstrating funds are available for the purchase of Wood Trails' water system and for the construction of the capital improvements necessary for CSWR-Texas to provide continuous and adequate service to existing customers.
- 54. CSWR-Texas has filed a capital improvement plan that includes an itemized budget, and the total cost of necessary capital improvements.
- 55. CSWR-Texas demonstrated the financial and managerial ability and stability to provide continuous and adequate service to the requested area.

Financial Assurance

56. There is no need to require CSWR-Texas to provide a bond or other financial assurance to ensure continuous and adequate service.

Feasibility of Obtaining Service from Adjacent Retail Public Utility

- 57. Wood Trails is currently serving customers and has sufficient capacity.
- 58. Obtaining service from an adjacent retail public utility would likely increase costs to customers because new facilities would need to be constructed. At a minimum, an interconnect would need to be installed in order to connect to a neighboring retail public utility.
- 59. It is not feasible to obtain service from an adjacent retail public utility.

Environmental Integrity and Effect on the Land

- 60. The requested areas will continue to be served with existing infrastructure.
- 61. There will be minimal effects on environmental integrity and on the land as a result of CSWR-Texas's planned upgrades, renovations, and repairs to the public water system.

Improvement of Service or Lowering Cost to Consumers

- 62. CSWR-Texas will continue to provide water service to Wood Trails' existing customers in the requested area.
- 63. Water service to the requested area expected to improve because CSWR-Texas intends to make upgrades, renovations, and repairs necessary to improve the safety and reliability of service.
- 64. The rates charged to customers in the requested area will not change as a result of the proposed transaction because CSWR-Texas will adopt Wood Trails' current tariff for the water system upon approval of the transaction.

Regionalization or Consolidation

65. It will not be necessary for CSWR-Texas to construct a physically separate water system to serve the requested area.

66. Because the requested area will not require construction of a physically separate water system, consideration of regionalization or consolidation with another retail public utility is not required.

Map, Tariff Pages, and Certificate

- 67. On August 26, 2024, Commission Staff emailed CSWR-Texas the proposed final map, tariff pages, and certificate related to this docket.
- 68. On September 3, 2024, CSWR-Texas filed the following:
 - a. CSWR-Texas's consent for concurring with the proposed final map, relevant tariff pages, and certificate; and
 - b. Wood Trails, consent form concurring with the proposed final map.
- 69. The proposed final map, relevant tariff pages, and certificate were included as attachments to the joint supplemental motion to admit evidence and proposed notice of approval, filed on September 11, 2024.

Informal Disposition

- 70. More than 15 days have passed since the completion of notice provided in this docket.
- 71. No person filed a protest or motion to intervene.
- 72. CSWR-Texas, Wood Trails, and Commission Staff are the only parties to this proceeding.
- 73. No party requested a hearing and no hearing is needed.
- 74. Commission Staff recommended approval of the application.
- 75. The decision is not adverse to any party.

II. Conclusions of Law

The Commission makes the following conclusions of law:

- 1. The Commission has authority over this proceeding under Texas Water Code (TWC) §§ 13.041, 13.241, 13.242, 13.244, 13.246, 13.251, and 13.301.
- CSWR-Texas and Wood Trails are retail public utilities as defined by TWC § 13.002(19) and 16 Texas Administrative Code (TAC) § 24.3(31).

- 3. The Commission processed the application as required by the TWC, the Administrative Procedure Act,¹ and Commission Rules.
- 4. The application meets the requirements of TWC § 13.244 and 16 TAC §§ 24.227, 24.233, and 24.239.
- 5. CSWR-Texas and Wood Trails, the applicants, provided notice of the application in compliance with TWC §§ 13.246 and 13.301(a)(2) and 16 TAC § 24.239.
- CSWR-Texas and Wood Trails have complied with the requirements of 16 TAC § 24.239(k) and (l) with respect to customer deposits.
- CSWR-Texas and Wood Trials completed the sale within the time frame required by 16 TAC § 24.239(m).
- After consideration of the factors in TWC § 13.246(c), CSWR-Texas demonstrated that it is capable of rendering continuous and adequate service to every customer in the requested area, as required by TWC § 13.251.
- CSWR-Texas demonstrated adequate financial, managerial, and technical capability for providing adequate and continuous service to the requested area, as required by TWC §§ 13.241(a) and 13.301(b).
- It is not necessary for CSWR-Texas to provide bond or other financial assurance under TWC §§ 13.246(d) and 13.301(c).
- 11. Regionalization and consolidation concerns under TWC § 13.241(d) do not apply in this proceeding, because construction of a physically separate water system is not required.
- 12. CSWR-Texas and Wood Trails demonstrated that the sale and transfer of Wood Trails' facilities and service area held under water CCN number 11880 to CSWR-Texas will serve the public interest and is necessary for the service, accommodation, convenience, or safety of the public under TWC § 13.301(d) and (e).
- 13. Under TWC § 13.257(r) and (s), CSWR-Texas and Wood Trails must record a certified copy of the map and certificate approved by this Notice of Approval, along with a boundary

description of the service area, in the real property records of Kerr County within 31 days of receiving this Notice of Approval and submit to the Commission evidence of the recording.

14. The requirements for informal disposition under 16 TAC § 22.35 have been met in this proceeding.

III. Ordering Paragraphs

In accordance with the preceding findings of fact and conclusions of law, the Commission enters the following orders.

- The Commission approves the sale and transfer of facilities and service area held by Wood Trails under CCN number 11880 to CSWR-Texas, to the extend provided in this Notice of Approval and as shown on the attached maps.
- 2. The Commission cancels Wood Trails' water CCN number 11880.
- The Commission amends CSWR-Texas's water CCN number 13290 to include the area previously included in Wood Trails' water CCN number 11880, as shown on the attached map.
- 4. The Commission approves the map and tariff pages attached to this Notice of Approval.
- 5. The Commission issues the certificate attached to this Notice of Approval.
- 6. CSWR-Texas must provide service to every customer or applicant for service within the approved area under water CCN number 13290 that requests service and meets the requirements of CSWR-Texas's water service policies, and such service must be continuous and adequate.
- 7. CSWR-Texas must comply with the recording requirements in TWC § 13.257(r) and (s) for the areas in Kerr County affected by the application and must submit to the Commission evidence of the recording no later than 45 days after receipt of the Notice of Approval.
- 8. Within ten days of the date of this Notice of Approval, Commission Staff must provide the Commission with a clean copy of CSWR-Texas's most current comprehensive tariff, including the tariff pages approved by this Notice of Approval, to be stamped *Approved* and retained by Central Records.

9. The Commission denies all other motions and any other requests for general or specific relief, if not specifically granted.
