#### MOTION TO WAIVE COMPENSATION PHASE AS MOOT

Jefferson Triangle Marine, L.P. ("Jefferson Triangle" or "Petitioner") files this Motion to Waive Compensation Phase as Moot.

Petitioner filed a Petition seeking the streamlined expedited release of property owned by Petitioner in Travis County, Texas, from water CCN No. 11144 held by Manville Water Supply Corporation ("Manville") on July 14, 2023. On August 16, 2023, the Administrative Law Judge ("ALJ") issued Order No. 2, finding the petition administratively complete. On August 24, 2023, Manville filed a motion to intervene and represented that Manville's Board of Directors has waived any compensation that may have been due to it under the compensation phase of these proceedings or otherwise.

#### I. MOTION

Under 16 Texas Administrative Code ("TAC") § 24.245(i), for a Streamlined Expedited Release proceeding, "[t]he amount of compensation, if any, will be determined after the commission has granted a petition." However, in this proceeding Manville has waived any compensation for release of the property owned by Petitioner. Therefore, Petitioner respectfully requests that, if the ALJ grants release of the property, the ALJ also issue an order at the same time finding that a compensation phase for this proceeding is unnecessary and moot as Manville has already stated that it has waived any compensation for the release.

### V. CONCLUSION

Petitioner respectfully requests that its Motion to Waive Compensation Phase as Moot be granted.
