# APPLICATION OF QUADVEST, LP TO§PUBLIC UTILITY COMMISSIONAMEND ITS CERTIFICATES OF§CONVENIENCE AND NECESSITY IN§HARRIS COUNTY§

#### **COMMISSION STAFF'S REQUEST FOR EXTENSION**

On July 26, 2023, Quadvest, LP (Quadvest) filed an application to amend its Certificates of Convenience and Necessity (CCN) Nos. 11612 and 20952 in Harris County. Quadvest filed supplemental information on July 28, 2023, August 16, 2023.

On November 17, 2023, the administrative law judge (ALJ) filed Order No. 5, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on sufficiency of notice by January 15, 2024<sup>1</sup>. Therefore, this pleading is timely filed.

#### I. REQUEST FOR EXTENSION OF TIME

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Staff is awaiting further information from the applicant and will require additional time to review. Accordingly, Staff respectfully requests an extension of time until January 23, 2024.

#### II. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to January 23, 2024, to file a recommendation on sufficiency of notice.
