#### COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE

On July 26, 2023, Quadvest, LP (Quadvest) filed an application to amend its certificates of convenience and necessity numbers 11612 and 20952 in Harris County under Texas Water Code (TWC) §§ 13.242 through 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 through 24.237. Quadvest filed supplemental information on July 28, 2023, August 16, 2023, October 16, 2023 and December 7 and 14, 2023.

On January 25, 2024, the administrative law judge (ALJ) filed Order No. 7, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of notice by January 29, 2024. Therefore, this pleading is timely filed.

#### I. SUFFICIENCY OF NOTICE

Staff has reviewed Quadvest's filed notice documentation and recommends that notice be deemed sufficient. Specifically, on December 7, 2023, Quadvest filed 1) a signed, dated, and notarized Affidavit of Notice to Current Customers, Neighboring Utilities, and Affected Parties and a signed, dated, and notarized Affidavit of Notice to Landowners; 2) a copy of the actual notice and maps sent to the affected parties; and 3) a signed, dated and notarized PUC Publisher's Affidavit form with tear sheets for the November 21, 2023 and November 28, 2023, publications in the *Houston Chronicle*. Quadvest also attached a list of the individuals and entities to whom notice was provided and included a copy of the notice and a copy of the maps deemed sufficient during administrative review.

#### II. CONCLUSION

Staff respectfully requests the entry of an order consistent with the foregoing.
