## TEXAS WATER UTILITIES, L.P.'S UNOPPOSED REQUEST FOR EXTENSION OF TIME

Texas Water Utilities, L.P. (TWU) files this unopposed request for extension of time to file a proof of notice with the Public Utility Commission of Texas (Commission). In support, TWU would show the following:

#### I. BACKGROUND

On July 31, 2023, TWU and SWWC Utilities, Inc. dba Hornsby Bend Utility Company, Inc. filed an application for sale, transfer, or merger of facilities and certificate rights in Travis County. On October 9, 2023, the administrative law judge (ALJ) issued Order No. 3, which established November 2, 2023, as the deadline for TWU to file proof of notice.

### **II. REQUEST FOR EXTENSION**

Pursuant to 16 Texas Administrative Code § 22.4(b), TWU requests the extension of the deadline to file proof of notice by one week, to November 9, 2023, to give TWU additional time to prepare the affidavits and accompanying documents. This request is not intended for the purpose of unnecessary delay, and has not been caused by neglect, indifference, or lack of diligence. TWU has conferred with Commission Staff who is unopposed to the requested extension.

#### **III. CONCLUSION**

TWU respectfully requests the issuance of an order granting its request and extending the deadline for TWU to file proof of notice with the Commission to November 9, 2023. TWU also requests that it be granted any further relief to which it may be justly entitled.
