JOINT SUPPLEMENTAL MOTION TO ADMIT EVIDENCE AND PROPOSED NOTICE OF APPROVAL

Texas Water Utilities, L.P. (TWU) and SWWC Utilities, Inc. dba Hornsby Bend Utility Company, Inc. (Hornsby Bend) (collectively, Applicants), together with the Staff (Staff) of the Public Utility Commission of Texas (Commission) and the Office of Public Utility Counsel (OPUC) (collectively, the Parties), file this Joint Supplemental Motion to Admit Evidence and Proposed Notice of Approval. In support thereof, the Parties show the following:

I. BACKGROUND

On July 31, 2023, Applicants filed an application for the sale, transfer, or merger of facilities and certificate rights in Travis County under the provisions of Texas Water Code (TWC) §§ 13.301 and 13.3011 and 16 Texas Administrative Code (TAC) § 24.239. On February 9, 2024, TWU withdrew its request for initial rates under TWC § 13.3011.

On May 7, 2024, the administrative law judge (ALJ) issued Order No. 13 Approving Sale and Transaction to Proceed, approving the transaction between TWU and Hornsby Bend and authorizing it to be completed.¹ On August 5, 2024, the ALJ issued Order No. 14 requiring that the Parties jointly file a proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs, by October 8, 2024.² Therefore, this pleading is timely filed.

II. JOINT SUPPLEMENTAL MOTION TO ADMIT EVIDENCE

The Parties move to admit the following evidence into the record of this proceeding:

 a. TWU and Hornsby Bend's proof of closing and confidential list of transferred customer deposits, filed on July 18, 2024 (Interchange Item Nos. 48 and 49);

Order No. 14 Finding Closing Documents Sufficient and Establishing Procedural Schedule (Aug. 5, 2024).

- b. Commission Staff's recommendation on sufficiency of the closing documents, filed on August 2, 2024 (Interchange Item No. 50);
- c. TWU's and Hornsby Bend's consent forms, filed on September 13, 2024 (Interchange Item Nos. 52 and 53);
- d. The final maps, certificates, and tariff pages attached to the joint supplemental motion to admit evidence, filed on October 8, 2024; and
- e. Commission Staff's second amended final recommendation on the transaction, including all attachments, filed on October 11, 2024 (Interchange Item No. 56).

III. PROPOSED NOTICE OF APPROVAL AND TARIFF CHANGES

The Parties respectfully request that the Commission adopt the findings of fact, conclusions of law, and ordering paragraphs contained in the Joint Proposed Notice of Approval provided as Attachment A. In addition, the Parties request approval of a change to the tariff approval process to effectuate the tariff changes relevant to this proceeding. In addition to the tariff changes in this proceeding, TWU has various recent or upcoming tariff-related deadlines in which new information and pages are being added to TWU's comprehensive tariffs. Further, each of these dockets is in a different stage of review and approval. Because it is not possible to know exactly when a notice of approval or final order will be filed in each docket, a docket may potentially produce an approved final tariff that includes information that is still being addressed in another docket. This process for filing and seeking approval of the comprehensive tariffs in a given docket has caused significant confusion in the past and has necessitated numerous delays and tariff corrections across TWU's dockets. As such, the Parties recommend that it is administratively simpler and more efficient to file and seek approval of the relevant tariff pages for each docket and to then include the relevant information from the approved tariff pages in the most current comprehensive tariffs to be filed as clean copies with Central Records in each docket.

Applicants note that they consented to certificate and tariff pages that contained agreed modifications.³ Those modifications included the following:

- Adding Bosque to the list of counties on the water certificate;
- Adding Caldwell to the list of counties on the sewer certificate;

- Adding language to both the water and sewer tariff to indicate that the water and sewer system improvement charges will not apply to systems transferred from Hornsby Bend;
- Adding the existing Hornsby Bend rates to the water and sewer tariff (the tariffs provided by Commission Staff were drafted as though TWU had not withdrawn its request for initial rates under TWC § 13.3011);
- Adding the current water pass-through charge applicable to the Austin's Colony public water system to the water tariff; and
- Making additions to the sewer tariff to reflect the approval of Docket No. 56317.⁴

IV. CONCLUSION

The Parties respectfully request that the Commission grant the Joint Supplemental Motion to Admit Evidence and adopt the attached Joint Proposed Notice of Approval.

JOINT PROPOSED NOTICE OF APPROVAL

This Order addresses the application of Texas Water Utilities, L.P. (TWU) and SWWC Utilities, Inc. dba Hornsby Bend Utility Company, Inc. (Hornsby Bend) for approval of the sale, transfer, or merger of facilities and certificate rights in Travis County. The Public Utility Commission of Texas (Commission) approves the following: (1) the transfer of all facilities and service areas held by Hornsby Bend under certificate of convenience and necessity (CCN) numbers 11978 and 20650 to TWU; (2) the amendment of TWU's CCN numbers 12983 and 20899 to include the facilities and service areas previously held by Hornsby Bend under CCN numbers 11978 and 20650; and (3) the cancellation of Hornsby Bend's CCN numbers 11978 and 20650.

I. Findings of Fact

The Commission makes the following findings of fact.

Applicants

- TWU is a Texas limited partnership registered with the Texas secretary of state under file number 800034797.
- TWU holds CCN number 12983 which obligates it to provide retail water service in its certificated service area in multiple counties, including Travis County.
- TWU holds CCN number 20899 which obligates it to provide retail sewer service in its certificated service area in multiple counties, including Travis County.
- 4. SWWC Utilities Inc. is a Delaware corporation registered with the Texas secretary of state under file number 800832416.

- SWWC Utilities Inc. is registered with the Texas secretary of state to do business as Hornsby Bend Utility Company, Inc.
- 6. Hornsby Bend holds CCN number 11978 which obligates it to provide retail water service in its certificated service area in Travis County.
- 7. Hornsby Bend holds CCN number 20650 which obligates it to provide retail sewer service in its certificated service area in Travis County.
- 8. Hornsby Bend owns a public water system registered with the Texas Commission on Environmental Quality (TCEQ) as Austin's Colony, under identification number 2270255.
- Hornsby Bend owns a sewer system permitted by the TCEQ as Austin's Colony, under Texas Pollutant Discharge Elimination System permit number WQ0013138001.
- SWWC Utilities, Inc. and TWU are both wholly owned subsidiaries of SouthWest Water Company, a Delaware corporation registered with the Texas secretary of state under file number 800099536.

Application

- 11. On July 31, 2023, TWU and Hornsby Bend filed the application at issue in this proceeding.
- 12. On August 28, 2023, TWU supplemented the application with revised mapping.
- 13. In the application, as supplemented, the applicants seek approval of the following:
 - a. the transfer of all of Hornsby Bend's facilities and certificated service areas under CCN numbers 11978 and 20650 to TWU;
 - the amendment of TWU's CCN numbers 12983 and 20899 to include the facilities and service areas previously included in Hornsby Bend's CCN numbers 11978 and 20650; and
 - c. the cancellation of Hornsby Bend's CCN numbers 11978 and 20650.
- 14. The total requested water service area is comprised of approximately 5,629.4 acres and 3,340 current customers.

- 15. The requested water service area is located approximately eight miles east of downtown Austin, Texas, and is generally bounded on the north by Decker Lake Road; on the east by Caldwell Lane; on the south by the Colorado River; and on the west by Farm-to-Market Road 973.
- 16. The total requested sewer service areas is comprised of approximately 14,442.1 acres and 3,767 current customers.
- 17. The requested sewer service area is comprised of two areas:
 - a. Requested sewer service area one is comprised of approximately 10,483.5 acres and 3,767 customer connections and is located approximately eight miles east of downtown Austin, Texas, and is generally bounded on the north by Braker Lane; on the east by Caldwell Lane; on the south by the Colorado River; and on the west by Farm-to-Market Road 973.
 - b. Requested sewer service area two is comprised of approximately 3,958.6 acres and zero customer connections and is located approximately one mile east of downtown Manor, Texas, and is generally bounded on the north by Littig Road; on the east by Hibbs Road; on the south by Blake Manor Road; and on the west by Farm-to-Market Road 973.
- 18. In Order No. 3 filed on October 9, 2023, the administrative law judge (ALJ) found the application, as supplemented, administratively complete.

Notice

- 19. On November 9, 2023, TWU filed the affidavit of Brian D. Bahr, director of rates and regulatory affairs for TWU, attesting that notice was provided to all current customers, neighboring utilities, and affected parties on November 3, 2023.
- 20. On November 9, 2023, TWU filed the affidavit of Mr. Bahr attesting that notice was provided to all owners of tracts of land of 25 acres or more that are wholly or partially located in the requested areas on November 3, 2023.
- 21. In Order No. 5 filed on November 21, 2023, the ALJ found notice sufficient.

Intervenor

22. In Order No. 6 filed on December 12, 2023, the ALJ granted the motion to intervene of the Office of Public Utility Counsel (OPUC).

Evidentiary Record

- 23. In Order No. 11 filed on April 19, 2024, the ALJ admitted the following evidence into the record:
 - a. The application of Hornsby Bend and TWU, including the confidential attachments, filed on July 31, 2023;
 - b. TWU's revised mapping, filed on August 28, 2023;
 - TWU's response to Commission Staff's first request for information, including all attachments, filed on September 7, 2023;
 - d. Commission Staff's recommendation on administrative completeness and notice and proposed procedural schedule, filed on October 3, 2023;
 - e. TWU's proof of notice and confidential mailing list, filed on November 9, 2023;
 - f. Commission Staff's recommendation on notice and proposed procedural schedule, filed on November 20, 2023;
 - g. OPUC's motion to abate, filed on December 15, 2023;
 - h. Commission Staff's final recommendation on the transaction, including the confidential attachment, filed on December 19, 2023;
 - i. TWU's withdrawal of request for initial rates, filed on February 9, 2024;
 - j. the joint motion to unabate and proposed procedural schedule, filed on February 9, 2024;
 - k. Commission Staff's amended final recommendation on the transaction, including all attachments, filed on February 15, 2024;
 - TWU's response to Order No. 9, including all confidential portions, filed on March 4 and 5, 2024;
 - m. TWU's supplemental response to Order No. 9, filed on March 14, 2024; and

- n. Commission Staff's recommendation on the capital improvement plan in response to Order No. 9, filed on March 22, 2024.
- 24. In Order No. __ filed on _____ __, 2024, the ALJ admitted the following evidence into the record:
 - a. TWU and Hornsby Bend's proof of closing and confidential list of transferred customer deposits, filed on July 18, 2024;
 - b. Commission Staff's recommendation on sufficiency of the closing documents, filed on August 2, 2024;
 - c. TWU and Hornsby Bend's consent forms, filed on September 13, 2024;
 - d. The final maps, certificates, and tariff pages attached to the joint supplemental motion to admit evidence, filed on October 8, 2024; and
 - e. Commission Staff's second amended final recommendation on the transaction, including all attachments, filed on October 11, 2024.

<u>Transfer</u>

- 25. In Order No. 13 filed on May 7, 2024, the ALJ approved the sale and transfer to proceed and required the applicants to file proof that the transaction had closed and that customer deposits had been addressed.
- 26. On July 18, 2024, the applicants filed proof that the sale had closed, and customer deposits and accrued interest had been transferred from Hornsby Bend to TWU.
- 27. In Order No. 14 filed on August 5, 2024, the ALJ found the closing documentation sufficient.

TWU's Compliance History

- 28. TWU has been subject to enforcement actions by the TCEQ in the past five years for non-compliance with rules, orders, or state statutes.
- 29. TWU has resolved, or is in the process of resolving, the compliance issues related to the open TCEQ enforcement actions listed in the application.
- 30. TWU does not have a history of continuing mismanagement or misuse of revenues as a utility provider.

- 31. The Commission's complaint records, which date back five years,
- 32. ¹ show 618 complaints against TWU that includes 11 open complaints that are being addressed. The remaining complaints have been reviewed and closed by the Commission's Consumer Protection Division.
- 33. TWU demonstrated a compliance history that is adequate for approval of the proposed transaction to proceed.

Adequacy of Existing Service

- 34. There are currently 3,340 water and 3,767 sewer customer connections in the requested areas that are being served by Hornsby Bend.
- The last TCEQ compliance investigation of the Austin's Colony public water system was on March 8, 2023.
- 36. The last TCEQ compliance investigation of the Austin's Colony sewer system was on March 30, 2021.
- 37. Hornsby Bend has two pending violations listed in the TCEQ database for the Austin's Colony public water system and the Austin's Colony sewer system and is working with the TCEQ to resolve the violations.
- 38. The Commission's complaint records, which date back five years, show 36 complaints against Hornsby Bend. The complaints have been reviewed and closed by the Commission's Consumer Protection Division.
- 39. There is no evidence in the record that Hornsby Bend has failed to comply with any Commission or TCEQ order.
- 40. No capital improvements are necessary for TWU to continue providing continuous and adequate service to the requested areas.

Need for Additional Service

- 41. There are 3,340 existing water customers and 3,767 existing sewer customers in the requested areas that are receiving service from Hornsby Bend and have an ongoing need for service.
- 42. This application is to transfer only existing facilities, customers, and service areas.
- 43. There is no evidence in the record indicating a need for additional service.

Effect of Approving the Transaction and Granting the Amendment

- 44. TWU will be the certificated entity for the requested areas and be required to provide continuous and adequate service to current and future customers in the requested areas.
- 45. There will be no adverse effect on landowners in the requested areas because the areas are currently certificated and served by Hornsby Bend.
- 46. All retail public utilities in the proximate areas were provided notice of the application and none filed a protest or motion to intervene.
- 47. There will be no effect on any retail public utility providing service in the proximate areas.

Ability to Serve: Managerial and Technical

- 48. TWU owns and operates numerous public water systems in Texas registered with the TCEQ and numerous sewer systems in Texas permitted with the TCEQ.
- 49. TWU employs or contracts with TCEQ-licensed operators who will be responsible for the operation of the public water system and sewer system being transferred.
- 50. TWU has the managerial and technical capability to provide continuous and adequate service to the requested areas.

Feasibility of Obtaining Service from Adjacent Retail Public Utility

- 51. Hornsby Bend is currently serving customers in the requested areas.
- 52. Obtaining service from an adjacent retail public utility would likely increase costs to customers because new facilities would need to be constructed; at a minimum, an interconnect would need to be installed to connect to a neighboring retail public utility.

53. It is not feasible to obtain service from an adjacent retail public utility.

Regionalization or Consolidation

- 54. It will not be necessary for TWU to construct a physically separate public water system or sewer system to serve the requested areas.
- 55. Because the requested areas will not require construction of a physically separate public water system or sewer system, consideration of regionalization or consolidation with another retail public utility is not required.

Ability to Serve: Financial Ability and Stability

- TWU's affiliate, SouthWest Water Company, is capable, available, and willing to cover temporary cash shortages and has a debt-service ratio of greater than 1.25. Therefore, TWU satisfies the leverage test.
- 57. SouthWest Water Company provided a written guarantee of coverage of temporary cash shortages and demonstrated that it has sufficient cash available to cover any projected operations and maintenance shortages during the first five years after the completion of the proposed transfer. Therefore, TWU satisfies the operations test.
- 58. TWU has demonstrated the financial capability and stability to pay for the facilities necessary to provide continuous and adequate water and sewer service to the requested areas.

Financial Assurance

59. There is no need to require TWU to provide a bond or other financial assurance to ensure continuous and adequate service.

Environmental Integrity and Effect on the Land

60. There will be no effect on environmental integrity or the land as a result of the transaction as the requested areas will continue to be served by existing facilities.

Improvement of Service or Lowering Costs to Consumers

61. TWU will continue to provide water and sewer service to Hornsby Bend's existing customers in the requested areas.

62. The current rates charged to existing customers will not change as a result of the proposed transaction because TWU will adopt the rates currently in effect in the tariffs for the acquired water system and sewer system upon final approval of the application.

Maps, Certificates, and Tariffs

- 63. On September 3, 2024, Commission Staff emailed the final proposed maps, certificates, and tariffs to the applicants.
- On September 13, 2024, Hornsby Bend and TWU filed their consent forms concurring with the final proposed maps, certificates, and tariffs as applicable.
- 65. On October 8, 2024, the final maps, certificates, and tariff pages were filed as attachments to the joint supplemental motion to admit evidence filed by the parties.

Informal Disposition

- 66. More than 15 days have passed since the completion of notice provided in this docket.
- 67. No person filed a protest or motion to intervene.
- 68. Hornsby Bend, TWU, Commission Staff, and OPUC are the only parties to this proceeding.
- 69. While OPUC initially requested a hearing, it later withdrew its request for a hearing, and the Commission ALJ determined that no hearing is needed.
- 70. Commission Staff recommended approval of the application.
- 71. The decision is not adverse to any party.

II. Conclusions of Law

The Commission makes the following conclusions of law.

- 1. The Commission has authority over this proceeding under Texas Water Code (TWC) §§ 13.041, 13.241, 13.242, 13.244, 13.246, 13.251, and 13.301.
- 2. TWU and Hornsby Bend are retail public utilities as defined by TWC § 13.002(19) and 16 Texas Administrative Code (TAC) § 24.3(31).
- 3. Notice of the application was provided in compliance with TWC §§ 13.246(a) and 13.301(a)(2) and 16 TAC § 24.239(b) and (e).

- 4. The application meets the requirements of TWC § 13.244 and 16 TAC § 24.233.
- 5. The Commission processed the application as required by the TWC, the Administrative Procedure Act,² and Commission Rules.
- 6. TWU and Hornsby Bend complied with the requirements of 16 TAC § 24.239(k) and (l) with respect to customer deposits.
- 7. TWU and Hornsby Bend completed the transfer within the time frame required by 16 TAC § 24.239(m).
- 8. After consideration of the factors in TWC § 13.246(c), TWU demonstrated that it is capable of rendering continuous and adequate service to every customer within the requested area, as required by TWC § 13.251.
- 9. TWU demonstrated adequate financial, managerial, and technical capability for providing adequate and continuous service to the requested area as addressed in TWC §§ 13.241(a) and 13.301(b).
- Regionalization and consolidation concerns under TWC § 13.241(d) do not apply in this
 proceeding because construction of a physically separate water system or sewer system is
 not required.
- 11. It is not necessary for TWU to provide a bond or other financial assurance under TWC §§ 13.246(d) and 13.301(c).
- 12. TWU and Hornsby Bend demonstrated that the transfer of Hornsby Bend's water and sewer facilities and the transfer of the service area held under CCN numbers 11978 and 20650 to TWU will serve the public interest and is necessary for the service, accommodation, convenience, or safety of the public as required by TWC §§ 13.246(b) and 13.301(d) and (e).
- 13. Under TWC § 13.257(r) and (s), TWU must record a certified copy of its certificates and the approved maps, along with a boundary description of the service area in the real property records of Travis County within 31 days of receiving this Notice of Approval and submit to the Commission evidence of the recording.

14. The requirements for informal disposition under 16 TAC § 22.35 have been met in this proceeding.


III. Ordering Paragraphs

In accordance with these findings of fact and conclusions of law, the Commission issues the following orders.


- The Commission approves the transfer of all facilities, customers, and certificated service area held by Hornsby Bend under CCN numbers 11978 and 20650 to TWU.
- The Commission amends TWU's CCN numbers 12983 and 20899 to include the service area previously held by Hornsby Bend under CCN numbers 11978 and 20650, as shown on the attached maps.
- 3. The Commission cancels Hornsby Bend's CCN numbers 11978 and 20650.
- 4. The Commission approves the maps and tariff pages attached to this Notice of Approval.
- 5. The Commission issues the certificates attached to this Notice of Approval.
- 6. TWU must provide service to every customer and qualified applicant for service within the approved area under CCN number 12983 that requests water service and meets the terms of TWU's water service policies, and such service must be continuous and adequate.
- 7. TWU must provide service to every customer and qualified applicant for service within the approved area under CCN number 20899 that requests sewer service and meets the terms of TWU's sewer service policies, and such service must be continuous and adequate.
- 8. TWU must comply with the recording requirements in TWC § 13.247(r) and (s) for the area in Travis County affected by the application and must submit to the Commission evidence of the recording no later than 45 days after receipt of this Notice of Approval.
- 9. Within ten days of the date this Notice of Approval is filed, Commission Staff must provide the Commission with a clean copy of TWU's most current, comprehensive water and sewer tariffs, including the tariff pages approved by this Notice of Approval, to be stamped Approved and retained by Central Records.

10.	The Commission denies all other motions and any other requests for general or specific relief, if not expressly granted herein.

The FTCCR will provide credits to customers taking service under this rate tarif
