COMMISSION STAFF'S REQUEST FOR EXTENSION

I. INTRODUCTION

On August 7,2023, SP Utility Company, Inc. (SP Utility) and Municipal Operations, Inc. (Municipal) (collectively, Applicants) filed an application for the sale, transfer of facilities and certificate rights in Harris County. The Applicants filed supplemental information on August 8, 2023, August 25, 2023, December 8, 2023, February 13, 2024, March 4, 2024, July 3, 2024, and December 20, 2024.

On December 30, 2024, the administrative law judge (ALJ) filed Order No. 18, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to provide final maps, certificates, and tariffs (if applicable), to the applicants for review and consent by January 27, 2025. Therefore, this pleading is timely filed.

II. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to prepare and review the final maps to be sent the Applicants for their review and consent. Therefore, Staff respectfully requests an extension of time until February 10, 2025, to provide final maps, certificates, and tariffs (if applicable), to the applicants for review and consent.

III. CONCLUSION

Staff respectfully requests the entry of an order extending Staff's deadline to provide final maps, certificates, and tariffs (if applicable), to the applicants for review and consent to February 10, 2025.
