#### COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF NOTICE AND PROPOSED PROCEDURAL SCHEDULE

On August 8, 2023, SP Utility Company, Inc (SP Utility) and Albury Manor Utility Company, Inc. (Albury Manor Utility) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Harris County, Texas.

On January 31, 2024, the administrative law judge filed Order No. 5, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of notice and to propose a procedural schedule by March 7, 2024. Therefore, this pleading is timely filed.

#### I. NOTICE

Staff has reviewed the proof of notice filed by SP Utility and recommends that the notice is sufficient. Specifically, SP Utility filed an affidavit, dated February 2, 2024, of Harrison Williams, President of SP Utility, attesting that notice was mailed to current customers, neighboring utilities, and affected parties on January 29, 2024. SP Utility also filed an affidavit, dated February 2, 2024, of Mr. Williams, attesting that notice was mailed to a landowner owning a tract of land over 25 acres wholly or partially inside the requested area on January 29, 2024. In addition, SP Utility included a copy of the notices provided, a list of the name and address of every person and entity to which notice was provided, and the general location and detailed maps deemed sufficient during administrative review. Therefore, Staff recommends that SP Utility's notice of the application be deemed sufficient for further processing of this matter.

### **II. PROPOSED PROCEDURAL SCHEDULE**

Staff recommends that notice be deemed sufficient. Therefore, Staff proposes the following procedural schedule:

## III. CONCLUSION

For the reasons detailed above, Staff recommends that notice be found sufficient and that the proposed procedural schedule be adopted. Staff respectfully requests the entry of an order consistent with these recommendations.

<sup>&</sup>lt;sup>2</sup> Under 16 TAC § 24.239(b) and (h), the deadline for Commission action is one hundred and twenty (120) days after the mailing or publication of notice, whichever occurs later. One hundred and twenty days after January 29, 2024, is May 28, 2024.
