ORDER NO. 6 FINDING NOTICE SUFFICIENT AND ADOPTING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of notice for the August 8, 2023 application of SP Utility Company, Inc. and Albury Manor Utility Company, Inc. for approval of the sale, transfer, or merger of facilities and certificate rights in Harris County.

On February 29, 2024, the applicants filed proof of notice documentation, including: (a) a signed and notarized affidavit that notice was mailed to all affected parties whose corporate or certificated service area are located within the two miles of the boundary of the requested areas; (b) proof that notice was provided to the county judge and groundwater conservation district in which the requested service areas are located; (c) a statement that there is one tract of land greater than 25 acres wholly or partially inside the requested CCN area who was also notified; (d) a list of the affected parties to whom notice was mailed; and (e) a copy of the requested service areas map, supplied to all affected parties along with affected customers.

On March 7, 2024, Commission Staff filed a recommendation on the sufficiency of notice and proposed a procedural schedule.

The administrative law judge (ALJ) finds notice sufficient.

The ALJ adopts the following procedural schedule for the continued processing of this docket:

120-day deadline for the Commission to approve the sale or require a hearing	May 28, 2024
