**SECOND AGREED REQUEST FOR EXTENSION**

On August 8, 2023, SP Utility Company, Inc (SP Utility) and Albury Manor Utility Company, Inc. (Albury Manor Utility) (collectively, Applicants) filed an application for approval of the sale and transfer of facilities and certificate rights in Harris County, Texas.

On March 12, 2024, the administrative law judge filed Order No. 7, directing the Applicants and the Staff (Staff) of the Public Utility Commission of Texas (Commission) (collectively, the Parties) to file a joint motion to admit evidence and a proposed order approving the sale and allowing the transaction to proceed by May 6, 2024. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code § 22.4(b), parties may request that the time allowed for the filing of any documents be extended for good cause. The Parties require additional time to finalize the joint motion to admit evidence and proposed order. Therefore, the parties respectfully request an extension until May 10, 2024 to file a joint motion to admit evidence and a proposed order approving the sale and allowing the transaction to proceed.

**II. CONCLUSION**

For the reasons discussed above, the Parties respectfully requests the entry of an order granting the extension.
