COMMISSION STAFF’S CLARIFICATION IN RESPONSE TO ORDER NO. 16

On August 8, 2023, SP Utility Company, Inc (SP Utility) and Albury Manor Utility Company, Inc. (Albury Manor Utility) (collectively, Applicants) filed an application for approval of the sale and transfer of facilities and certificate rights in Harris County, Texas.

On December 6, 2024, the administrative law judge (ALJ) filed Order No. 16, directing the Applicants to file their signed consent forms with the Public Utility Commission of Texas (Commission) by December 11, 2024. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Due to an unresolved error in the tariff,¹ Commission Staff (Staff) provided the Applicants with a corrected tariff and consent forms on December 5, 2024, indicating that such consent forms must be filed by December 12, 2024. In error, Staff failed to inform the ALJ of the schedule change. Accordingly, Staff respectfully requests that the Applicants be allowed to file their consent forms by December 12, 2024.

II. CONCLUSION

For the reasons discussed above, the Parties respectfully requests the entry of an order allowing the Applicants file their consent forms by December 12, 2024.
