**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On August 8, 2023, SP Utility Company, Inc (SP) and Albury Manor Utility Company, Inc. (Albury Manor) (collectively, Applicants) filed an application for approval of the sale and transfer of facilities and certificate rights in Harris County, Texas.

On August 9, 2023, the administrative law judge (ALJ) filed Order No. 1, requiring the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the application and proposed notice by September 7, 2023. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. Staff is conferring with the Applicants on some additional information and requires additional time for the Applicants to supplement the application and for Staff to file a recommendation thereafter. Therefore, Staff respectfully requests that the deadline to file its recommendation on the administrative completeness of the application and proposed notice be extended until October 26, 2023.

**II. CONCLUSION**

For the reasons discussed above, Staff respectfully requests the entry of an order granting the extension.
