(“ETI”) submits this agreed order of presentation and waiver of cross-examination on behalf of itself, the Public Utility Commission of Texas Staff (“Staff”), the Office of Public Utility Council, Texas Industrial Energy Consumers, Americans for Affordable Clean Energy, and Walmart Inc. (“Walmart”) (collectively, the “Parties”).¹ The following parties have stated that they do not intend to participate at the April 5, 2024 hearing, and thus, will not be cross examining any witnesses: El Paso Electric Company, Sierra Club, and Southwestern Public Service Company.




