APPLICATION OF CENTERPOINT ENERGY HOUSTON ELECTRIC, LLC, TO AMEND A CERTIFICATE OF CONVENIENCE AND NECESSITY FOR A 138-KV TRANSMISSION LINE WITHIN CHAMBERS COUNTY

SOAH ORDER NO. 2: MEMORIALIZING PREHEARING CONFERENCE; FINDING APPLICATION ADMINISTRATIVELY COMPLETE; ADOPTING PROCEDURAL SCHEDULE; SETTING HEARING ON THE MERITS

On September 19, 2023, a prehearing conference convened in this matter. The applicant, CenterPoint Energy Houston Electric, LLC, and staff of the Public Utility Commission of Texas (Commission) appeared through counsel.

I. SUFFICIENCY OF THE APPLICATION

On September 13, 2023, Staff filed comments recommending that the application be found sufficient. Pursuant to Staff's comments, the ALJs find the application sufficient and complete for further review.

II. PROCEDURAL SCHEDULE

The proposed procedural schedule, as agreed to by the parties and submitted by the Applicants on September 19, 2023, is **ADOPTED**, as set out below, and shall govern this proceeding unless otherwise ordered.

III. OTHER PROCEDURES

In addition, the following deadlines shall apply:

No later than 3:00 p.m. on November 7, 2023, the parties SHALL comply with the following prehearing requirements:

- Applicants **SHALL** arrange to have a court reporter transcribe the hearing.
- Applicants SHALL file a list of persons who have signed the Protective Order.
- Each party **SHALL** file a witness list identifying all witnesses the party expects to call to testify during the hearing and identifying its witnesses, if any, for whom all other parties waived cross-examination.
- Each party **SHALL** file a list of all exhibits it intends to offer at the hearing (including, for example, on cross-examination). The list shall identify any exhibit containing Protected Materials or Highly Sensitive Protected Materials under the Protective Order issued in this case.
- The parties **SHALL** deliver to the Administrative Law Judge (ALJ) at the State Office of Administrative Hearings, Room 504, 5th Floor, William P. Clements Building, 300 West 15th Street, Austin, Texas 78701, one electronic copy (USB drive or CD) of all exhibits the party intends to offer.¹
- The parties SHALL deliver to the court reporter, after consulting with the
 court reporter about how to do so, one electronic copy of all exhibits the
 party intends to offer, along with a copy of the party's witness list and
 exhibit list. The electronic copy of the parties' exhibits submitted to the
 court reporter will be maintained as the record copy.
- The parties SHALL exchange a marked copy of all exhibits not containing Protected Materials or Highly Sensitive Protected Materials that they

intend to offer at the hearing.² In compliance with 16 Texas Administrative Code § 22.71(d) and the Protective Order, any party intending to offer exhibits containing Protected Materials or Highly Sensitive Protected Materials **SHALL** also provide those exhibits to the other parties who have signed the Protective Order.

• If the parties plan to use a file-sharing site to exchange exhibits, the party that will host the site shall email the name of the file-sharing site to be used to Erin Hurley (at Erin.Hurley@soah.texas.gov) and Mavis Chase (at mavis.chase@soah.texas.gov) as soon as practicable, but no later than November 2, 2023, so that SOAH's IT personnel can determine whether it meets SOAH's security requirements so that the ALJ can use the file-sharing site as well.

All exhibits **SHALL** be marked with the offering party's name and the exhibit number. Exhibits should be numbered sequentially, and multipage documents shall be paginated or Bates-stamped. Exhibits not meeting a requirement in this Order may not be admitted into the record absent good cause.

Prior to the hearing, the parties **SHALL** provide to witnesses all documents necessary for their effective participation in the hearing. Parties should also speak to the witnesses they intend to call to testify and provide them the necessary videoconferencing information.

IV. HEARINGS

The hearing on route adequacy (if requested by October 6, 2023) will

convene at 9:00 a.m. on October 18, 2023. If a route adequacy hearing is not

requested on or before October 6, 2023, this hearing on route adequacy is

automatically canceled.

A prehearing conference will convene at 10:00 a.m. on November 7, 2023.

The hearing on the merits will convene at 9:00 a.m. on November 9-

10, 2023. The hearing is expected to last two days.

All proceedings in this case will be held via Zoom videoconference. Attend the

V. REQUIREMENT FOR STATEMENTS OF POSITION OR PREFILED TESTIMONY

Any intervenor who does not file written testimony or a position statement by that date will be dismissed from this case and prohibited from further participation. See 16 Tex. Admin. Code §§ 22.124, 22.161.
