COMMISSION STAFF'S PROPOSED PROCEDURAL SCHEDULE

On August 15, 2023, Aqua Water Supply Corporation (Aqua WSC) filed an application to decertify a portion of its sewer Certificate of Convenience and Necessity (CCN) No. 20962 in Bastrop County under Texas Water Code (TWC) § 13.254(a) and 16 Texas Administrative Code (TAC) § 24.245(d). Aqua WSC filed supplemental information on October 26, 2023, November 8, 2023 and December 5, 2024.

On January 23, 2024, the administrative law judge (ALJ) filed Order No. 5, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a proposed procedural schedule for continued processing of the application by January 31, 2024. Therefore, this pleading is timely filed.

I. PROPOSED PROCEDURAL SCHEDULE
