has submitted an application with the Public Utility Commission of Texas (Commission) to amend uncertificated area to CCN No. 20816 and to purchase sewer facilities in Calhoun County, TX from: Guadalupe-Blanco River Authority.

The requested area overlaps the district boundaries of Calhoun County Drainage District 11. If this district does not request a public hearing, the Commission shall determine that the district is consenting to <u>Undine Texas Environmental</u>, <u>LLC</u>'s request to provide retail sewer utility service in the requested area.

The sale is scheduled to take place if approved by the Commission (Texas Water Code § 13.301). The transaction and the transfer of the CCN includes the following subdivision: <u>Crestview</u> Subdivision.

The requested area includes <u>68</u> customer connections, is located approximately <u>4.2</u> mile(s) <u>southwest</u> of downtown <u>Port Lavaca</u>, Texas, and is generally bounded on the north by <u>Farm to Market 2433</u>; on the east by <u>the intersection of Farm to Market 2433 and Sweetwater Road</u>; on the south by <u>the intersection of Sweetwater Road and Sanders Road</u>; and on the west by <u>Sanders Road</u>.

The requested area includes approximately <u>60</u> acres, comprised of uncertificated area to amend (add) to Undine Texas Environmental, LLC (CCN No. 20816).

The application proposes the addition of approximately <u>60</u> acres to CCN No. 20816.

See enclosed maps showing the requested area.

This transaction will not have an effect on the current customer's rates and services.

Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P.O. Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter

requesting intervention to the commission which is received by that date. The letter must include the person's name, address, email address and fax mmber if applicable.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.

A landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the requested area, may file a written request with the Commission to be excluded from the requested area ("opt out") within (30) days from the date that notice was provided by the Utility. All opt out requests must include a large-scale map, a metes and bounds description of the landowner's tract of land, landowner's name, address, email address and fax number, if applicable.

A landowner that opts out from the requested area releases the applicant's obligation to provide retail water or sewer utility service to the removed land for any reason.




