ORDER NO. 5 FINDING NOTICE, AS SUPPLEMENTED, SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of notice, as supplemented, provided by Guadalupe-Blanco River Authority and Undine Texas Environmental, LLC (collectively, applicants).

On December 14, 2023, applicants filed (a) the affidavit of Vance Tillman, chief financial officer of Undine, attesting that (a) there are no owners of tracts of land that are at least 25 acres that are wholly or partially included in the area proposed to be certified; and (b) individual notice, along with maps, was provided by first-class mail, to current customers, neighboring utilities, and affected parties on December 4, 2023. Applicants filed the confidential list of recipients that received individual notice. On December 28, 2023, applicants supplemented notice by filing the publishers' affidavit and tear sheets from the *Port Lavaca Wave*, a newspaper of general circulation in Calhoun County, attesting to publication on December 13 and 20, 2023.

On January 18, 2024, Commission Staff filed a recommendation on the sufficiency of notice, as supplemented, and proposed a procedural schedule.

The administrative law judge finds notice, as supplemented, sufficient and establishes the following procedural schedule for the continued processing:

Deadline for Commission Staff to request a hearing or file a recommendation on approval of the sale and CCN amendment	February 28, 2024
Deadline for applicants to file a response to Commission Staff's recommendation on approval of the sale and allowing the transaction to proceed	March 6, 2024

Deadline for any party to request a hearing	March 6, 2024
If no hearing is requested, deadline for the parties to file a joint motion to admit evidence and a proposed order approving the sale and allowing the transaction to proceed	March 27, 2024
120-day deadline for Commission to approve the sale or require a hearing	April 18, 2024
