COMMISSION STAFF'S REQUEST TO AMEND THE PROCEDURAL SCHEDULE

I. INTRODUCTION

On August 16, 2023, Guadalupe-Blanco River Authority (GBRA) and Undine Texas Environmental, LLC (Undine T.E.) (collectively, Applicants) filed an application for the sale, transfer, or merger of facilities and certificate rights in Calhoun County under the provisions of Texas Water Code § 13.301 and 16 Texas Administrative Code § 24.239.

On January 22, 2024, the administrative law judge filed Order No. 5, directing the Staff (Staff) of the Public Utility Commission of Texas to request a hearing or file a recommendation on approval of the sale and the certificate of convenience and necessity (CCN) amendment by February 28, 2024. Therefore, this pleading is timely filed.

II. REQUEST TO AMEND THE PROCEDURAL SCHEDULE

Pursuant to 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs more time to prepare its recommendation on approval of the sale and the CCN amendment. Staff requests that the procedural schedule be amended in this proceeding as follows:

Deadline for Commission Staff to file a recommendation on approval of the sale and CCN amendment	March 6, 2024
Deadline for Applicants to file a response to Commission Staff's recommendation on approval of the sale and allowing the transaction to proceed	March 13, 2024
Deadline for any party to request a hearing	March 13, 2024

If no hearing is requested, deadline for the	March 27, 2024
parties to file a joint motion to admit evidence	
and a proposed order approving the sale and	
allowing the transaction to proceed	
120-day deadline for Commission to approve	April 18, 2024
the sale or require a hearing

Staff respectfully requests that the procedural schedule in this proceeding be amended as detailed above.
