**APPLICANTS' STATUS REPORT**

**I. Background**

On April 10, 2024, the Administrative Law Judge (ALJ) filed Order No. 8, Approving the Sale and Transfer to Proceed, and ordering that Applicants Guadalupe-Blanco River Authority (GBRA) and Undine Texas Environmental, LLC (UTE) (collectively, the Applicants) continue to provide monthly status reports. Applicants hereby provide this status report for August 2024.


**II. Status Update**

This application was filed concurrently with the application by GBRA and Undine Texas, LLC for the sale, transfer or merger of facilities and certificate rights under PUC Docket No. 55377 (the "Water Application"). Applicants intend to complete both transactions at the same time. Because the Water Application remains pending, the closing of this transaction remains pending. UTE reports there have not been any material changes in its financial, managerial, and technical capability to provide continuous and adequate service to the requested area and the Applicant's service area. The undersigned counsel for UTE represents that GBRA has authorized them to file this Response on GBRA's behalf.
