**ORDER NO. 13**  
**FINDING CLOSING DOCUMENTS SUFFICIENT, GRANTING EXTENSION, AND**  
**ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's June 9, 2025 recommendation regarding the closing documentation filed by Guadalupe-Blanco River Authority and Undine Texas Environmental, LLC and the proposed procedural schedule for continued processing. On May 22, 2025, the applicants filed closing documents and a statement that there are no outstanding customer deposits to be transferred. Commission Staff recommended the closing documentation be found sufficient.

The administrative law judge finds the closing documentation sufficient and finds that there are no customer deposits.


On June 13, 2025, Commission Staff filed a request for extension. Commission Staff's Infrastructure Division requires additional time to complete the review and finalizing of the maps, certificates, and tariffs before providing them to petitioners. Therefore, Commission Staff requests the deadline to the petitioners for review be extended to July 15, 2025.

The following procedural schedule applies for continued processing of this docket:
