COMMISSION STAFF'S REQUEST FOR EXTENSION

On August 24, 2023, Shorewood Forest Water System (Shorewood Forest) filed an application for a class D rate adjustment under Texas Water Code (TWC) § 13.1872 and 16 Texas Administrative Code (TAC) § 24.49. Shorewood Forest holds certificate and convenience and necessity (CCN) number 12371 and indicates there are 100 active water connections.

On August 25, 2023, the administrative law judge (ALJ) filed Order No. 1, directing the Commission Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments on the administrative completeness of the application and notice by September 25, 2023. Along with Staff comments, Order No. 1 also directed Staff to file a recommendation on final disposition by September 25, 2023. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION OF TIME

Under 16 Texas Administrative Code § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Staff and the applicant are working together to resolve some discrepancies in the application and need the time to coordinate a supplemental filing. Staff respectfully request an extension of time until October 25, 2023.

II. CONCLUSION

Staff respectfully request the entry of an order extending Staff's deadline to October 25, 2023, to file comments on the administrative completeness of the application and notice and a recommendation on final disposition.
