**ORDER NO. 8  
ADMITTING EVIDENCE**

This Order addresses the February 2, 2024 joint motion to admit evidence filed by CSWR-Texas Utility Operating Company LLC, Vineyard Ridge Water Supply, LLC, and Commission Staff; the February 27, 2024 joint supplemental motion to admit evidence filed by CSWR-Texas, Vineyard, and Commission Staff; the February 29, 2024 motion to admit evidence filed by CSWR-Texas; and the April 5, 2024 motions to admit supplemental evidence filed by Commission Staff and by CSWR-Texas.
