### JOINT REQUEST FOR AN EXTENSION

On August 29, 2023, CSWR-Texas Utility Operating Company, LLC and Vineyard Ridge Water Supply, LLC filed an application for approval of the sale, transfer, or merger of facilities and certificate of convenience and necessity rights in Gillespie County under Texas Water Code § 13.301 and Texas Administrative Code (TAC) § 24.239.

On June 20, 2024, the administrative law judge filed Order No. 11, directing the parties to jointly file a proposed notice of approval by August 20, 2024. Therefore, this pleading is timely filed.
