Pursuant to Texas Water Code § 13.257(r) and (s), CSWR-Texas Utility Operating Company, LLC (CSWR-Texas), holder of water Certificate of Convenience and Necessity (CCN) No. 13290, hereby files this Boundary Description for the CSWR-Texas water system, which is located in Gillespie County, Texas.

In accordance with the aforementioned statute, CSWR-Texas affirmatively states that its water service area included in the aforementioned CCN is as follows:

The service area is located 12.7 miles northwest of downtown Johnson City, Texas, and is generally bounded on the north by North Grape Creek Road, on the east by North Grape Creek Road, on the south by Ranch to Market Road 2721, and on the west by Klein Ahrens Road.

The service area includes approximately 660.7 acres and 76 customer connections in Gillespie County.

The service areas are further depicted in the attached PUC certified map.

The Boundary Description is being filed on behalf of and at the request and instruction of CSWR-Texas based upon information and belief. CSWR-Texas specifically authorizes the filing of this Boundary Description to comply with Texas Water Code § 13.257(r) and (s) and its associated rules and regulations.




