COMMISSION STAFF'S REQUEST FOR EXTENSION

On September 1, 2023, Concho Rural Water Corporation (Concho), certificate of convenience and necessity (CCN) No. 11361, filed an application to implement a pass-through gallonage charge (PTGC) for its Group 2 customers under 16 Texas Administrative Code (TAC) § 24.25(b)(2), regarding the January 2023-June 2023 true-up report filed in compliance with its approved PTGC adjustment provision in its Water Utility Tariff, approved in the final order of Docket No. 49892.

On October 3, 2023, the administrative law judge (ALJ) filed Order No. 3, establishing a deadline of October 30, 2023, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation regarding the revised notice, along with a proposed procedural schedule for continued processing. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff recently submitted a request for information (RFI) to Concho and requires additional time to allow the applicant to respond and for Staff to receive and review any responses. Therefore, Staff respectfully requests a deadline of November 28, 2023 for Concho to submit its responses to Staff's RFIs, and for Staff to be given a deadline of December 12, 2023 to file a supplemental recommendation regarding the revised notice, along with a proposed procedural schedule for continued processing

II. CONCLUSION

For the reasons discussed above, Staff respectfully recommends an order based on the foregoing.
