COMMISSION STAFF'S THIRD REQUEST FOR EXTENSION

On September 1, 2023, Concho Rural Water Corporation (Concho), Certificate of Convenience and Necessity (CCN) No. 11361, filed an application to implement a pass-through gallonage charge (PTGC) for its Group 2 customers in accordance with its January 2023-June 2023 true-up report filed in compliance with its approved PTGC adjustment provision in its Water Utility Tariff, approved in the final order of Docket No. 49892.

On December 12, 2023, the administrative law judge (ALJ) filed Order No. 5, requiring Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation regarding the revised notice, along with a proposed procedural schedule for continued processing by January 19, 2024. Therefore, this pleading is timely filed.

I. REQUEST FOR AN EXTENSION

Under 16 TAC § 22.4(b), a party may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to review Concho's supplemental information filed on December 14, 2023. Accordingly, Staff respectfully requests a new deadline of January 26, 2024 to file a supplemental recommendation regarding the revised notice, along with a proposed procedural schedule for continued processing.

II. CONCLUSION

Staff respectfully requests the entry of an order consistent with the above request for extension.
