**COMMISSION STAFF’S SUPPLEMENTAL RECOMMENDATION ON REVISED  
NOTICE, AND PROPOSED PROCEDURAL SCHEDULE**

On September 1, 2023, Concho Rural Water Corporation (Concho) Certificate of Convenience and Necessity (CCN) No. 11361, filed an application to implement a pass-through gallonage charge (PTGC) for its Group 2 customers under 16 Texas Administrative Code (TAC) § 24.25(b)(2), regarding the January 2023-June 2023 true-up report filed in compliance with the PTGC adjustment provision in its Water Utility Tariff approved in the final order of Docket No. 49892. Concho filed supplemental information on November 16, 2023 and December 14, 2023.

On January 25, 2024, the administrative law judge (ALJ) filed Order No. 6, establishing a deadline of January 26, 2024, for the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a supplemental recommendation regarding the sufficiency of the application, revised notice, along with a proposed procedural schedule for continued processing. Therefore, this pleading is timely filed.

**I. RECOMMENDATION ON APPLICATION SUFFICIENCY AND NOTICE**

Staff has reviewed Concho’s supplemented application and, as detailed in the attached memorandum of Vonetta Jackson, Rate Regulation Division, recommends that the application be deemed sufficient under 16 TAC § 24.25(b)(2)(F). Further, Staff has reviewed the content of Concho’s notice to customers and recommends that it satisfies the requirements of 16 TAC § 24.25(b)(2)(F)(ii).

## II. PROCEDURAL SCHEDULE

In accordance with its sufficiency recommendation, Staff proposes the following procedural schedule:
