COMMISSION STAFF'S REQUEST FOR EXTENSION

On September 1, 2023, Concho Rural Water Corporation (Concho) filed an application regarding the January 2023 through June 2023 true-up report in compliance with the Commission's November 18, 2021 Final Order in Docket No. 49892¹ and Order No. 4 in Docket No. 52663,² requesting approval for pass-through rate change for Group 2 customers, with an effective date of September 11, 2023.

On September 7, 2023, the administrative law judge (ALJ) filed Order No. 1, instructing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file a recommendation on the sufficiency of the application and notice, and propose a procedural schedule, if appropriate by October 2, 2023. Therefore, this pleading is timely filed.

I. REQUEST FOR AN EXTENSION

Under 16 TAC § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff requires additional time to review Concho's application. Accordingly, Staff respectfully requests the entry of an order extending the deadline to file a recommendation on the sufficiency of the application be extended to October 9, 2023.
