STACIE SMITH'S RESPONSE TO REQUEST FOR INFORMATION QUESTION NOS. STAFF 1-1 THROUGH 1-3

Stacie Smith files this response to Commission Staff's First Request for information. Stacie Smith stipulates that responses to requests for information can be treated by all parties as if the answers were filed under oath.

STAFF 1-1

Please admit if you are requesting a waiver to 16 Texas Administrative Code (TAC) § 24.169(a)(4) which reads as follows:

One meter is required for each residential, commercial, or industrial service connection. An apartment building, condominium, manufactured housing community, or mobile home park may be considered by the utility to be a single commercial facility for the purpose of these sections. The commission may grant an exception to the individual meter requirement if the plumbing of an existing multiple use or multiple occupant building would prohibit the installation of individual meters at a reasonable cost or would result in unreasonable disruption of the customary use of the property.

Stacie Smith responds as follows:

Stacie Smith denies that her original petition is requesting a waiver to 16 Texas Administrative Code (TAC) § 24.169(a)(4) because the PUC lacks jurisdiction. (See Docket No. 45034 – Order No. 2: Order of Dismissal) As a water supply corporation, Liberty City Water Supply Corporation is specifically excluded from the definition of a "water and sewer utility" pursuant to 16 TAC § 24.3(54).

Stacie Smith's petition to the PUC of Texas contests the **cost of obtaining new service** from Liberty city WSC under Texas Water Code (TWC) § 13.43(g).

Please state the rule that grants a waiver to 16 TAC § 24.169(a)(4) or reference a PUC Docket Number(s) where an exception was granted to the individual meter requirement per 16 TAC § 24.169(a)(4).

Stacie Smith responds as follows:

There is no rule that grants a waiver to the individual meter requirement because water supply corporations are specifically excluded from the definition of a "water and sewer utility" pursuant to 16 TAC § 24.3(54). PUC Docket No. 45034 – Order No. 2 dismissed a petition for an exception to the individual mater requirement because "the Commission does not have the authority to grant an exception to the individual meter requirement for customers of water supply corporations."

STAFF 1-3

Please explain in detail how your situation qualifies for an exception as explained in 16 TAC § 24.169(a)(4).

Stacie Smith responds as follows:

Liberty City Water Supply Corporation is exempt from the Public Utility Commission of Texas regulations; therefore, I (Stacie Smith) am compelled to follow the tariff of this sole water provider to my property.
