#### COMMISSION STAFF'S REQUEST FOR AN EXTENSION

On October 30, 2023, Stacie Smith filed an appeal of the cost of obtaining service from Liberty City Water Supply Corporation (Liberty City WSC) under Texas Water Code § 13.043(g) and 16 Texas Administrative Code (TAC) § 24.101(g). Ms. Smith stated that the total estimated cost to obtain service from the WSC is \$4,003.00.

On February 9, 2024, the administrative law judge filed Order No. 3, directing the Staff (Staff) of the Public Utility Commission of Texas to file a recommendation on the sufficiency of notice and to propose a procedural schedule by February 20, 2024. Therefore, this pleading is timely filed.

#### I. REQUEST FOR AN EXTENSION

Under 16 TAC § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. On January 29, 2024, Staff filed its first Request for Information (RFI) to Liberty City WSC. Liberty City WSC has not yet filed a response to Staff's RFI, and Staff needs to review Liberty City WSC's response before proposing a procedural schedule for continued processing of this docket. Therefore, Staff respectfully requests an extension of time until March 5, 2024, to file a recommendation on the sufficiency of notice and to propose a procedural schedule.

#### II. CONCLUSION

For the reasons discussed above, Staff respectfully requests the entry of an order granting Staff's extension request.
