SECOND JOINT REQUEST FOR EXTENSION

On October 31, 2023, Stacie Smith filed an appeal of the cost of obtaining service from Liberty City Water Supply Corporation (Liberty City WSC) under Texas Water Code § 13.043(g) and 16 Texas Administrative Code (TAC) § 24.101(g). Ms. Smith stated that the total estimated cost to obtain service from the WSC is \$4,003.00.

On May 30, 2024, the administrative law judge filed Order No. 6, directing the parties to file a proposed order with findings of fact, conclusions of law, and ordering paragraphs (Proposed Order) by July 26, 2024.

On July 26, 2024, Commission Staff filed a request for extension of time to complete its draft of the Proposed Order and Liberty City WSC filed its comment stating it had no objection to the Commission Staff's request for extension of time.

On July 29, 2024, Order No. 7 granted the Commission Staff's request for extension until August 9, 2024 to file the Proposed Order.

On August 8, 2024, the parties filed a joint request for extension of time to complete the Proposed Order.

On August 9, 2024, the ALJ issued Order No. 8 granting the parties' request for extension until August 21, 2024 to file the Proposed Order.

Under 16 TAC § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. The parties are close to completing the Proposed Order but require some additional time to complete a final review and revisions. Therefore,

Commission Staff and Liberty City WSC jointly request that the deadline to file the Proposed Order be extended until August 27, 2024.

I. CONCLUSION

For the reasons stated above, the parties respectfully request the entry of an order granting the request for extension.
