#### LIBERTY CITY WATER SUPPLY CORPORATION'S RESPONSE TO ORDER NO.1

Liberty City Water Supply Corporation (Liberty City WSC) files this response to Order No.1 and respectfully shows the following:

#### I. BACKGROUND

On October 31, 2023, Stacie Smith (Ms. Smith) filed with the Public Utility Commission of Texas (Commission) an appeal of the cost of obtaining service from Liberty City WSC under Texas Water Code (TWC) § 13.043(g) and Public Utility Commission's Substantive Rule §24.101(g).

On November 1, 2023, the administrative law judge (ALJ) issued Order No. 1, directing Ms. Smith, Liberty City WSC, and Commission Staff to file recommendations regarding how to proceed with the appeal and to propose a procedural schedule by November 30, 2023. Therefore, this pleading is timely filed.

#### II. PROCEDURAL SCHEDULE

Liberty City WSC agrees with the Proposed Procedural Schedule set forth in Paragraph III of Commission Staff's Comments on the Administrative Completeness of the Appeal and Notice of Proposed Procedural Schedule filed on November 30, 2023.
