The sale is scheduled to take place if approved by the Commission (Texas Water Code § 13.301). The transaction and the transfer of the CCN includes the following subdivision: <u>New Alsace.</u>

The requested area is located approximately 0.8 mile(s) west of downtown <u>Castroville</u>, Texas, and is generally bounded on the north by <u>Medina Canal</u>; on the east by <u>River Bluff Road</u>; on the south by <u>County Road 4516</u>; and on the west by <u>the intersection of County Road 4516 and Double Gate Road</u>.

The requested area includes <u>67</u> customer connections and approximately <u>176</u> acres to transfer from New Alsace WSC (CCN No. 12558) to Yancey WSC (CCN No. 11463).

The application proposes the subtraction of approximately <u>176</u> acres from CCN No. 12558 and the addition of approximately <u>176</u> acres to CCN No. 11463.

See enclosed maps showing the requested area.

The proposed transaction may change the current customers' rates and services to the current approved rates and services of Yancey Water Supply Corporation, which are lower than the current rate for a 5/8" meter for <u>New Alsace Water Supply Corporation</u>. Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date. The letter must include the person's name, address, email address and fax number if applicable.


If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held. SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.


A landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the requested area, may file a written request with the Commission to be excluded from the requested area ("opt out") within (30) days from the date that notice was provided by the Utility. All opt out requests must include a large-scale map, a metes and bounds description of the landowner's tract of land, landowner's name, address, email address and fax number, if applicable.

A landowner that opts out from the requested area releases the applicant's obligation to provide retail water or sewer utility service to the removed land for any reason.
