COMMISSION STAFF’S REQUEST FOR EXTENSION

On November 21, 2023, Midway Water Utilities, Inc. (Midway Water) filed an application for a minor tariff change under 16 Texas Administrative Code (TAC) § 24.25(b)(2). Midway Water seeks to change the name of the Transfer Fee set forth in Midway Water’s water and wastewater tariffs to Service Initiation Fee. Midway Water also proposes other conforming definitional revisions. Midway Water requests an effective date of December 1, 2023.

On December 21, 2023, the administrative law judge filed Order No. 2, directing the Staff (Staff) of the Public Utility Commission of Texas (Commission) to file comments and recommendations regarding the sufficiency of the application, the appropriate form of notice, if any, and the proper method for processing this docket by January 22, 2024. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Pursuant to 16 TAC § 22.4(b), a party may request that the time allowed for the filing of any documents be extended for good cause. Staff requires additional time to review Midway Water’s application and its responses to Staff’s requests for information, and to file its recommendations thereafter. Therefore, Staff respectfully requests the entry of an order extending Staff’s deadline to file its recommendations to January 29, 2024.

Staff respectfully requests the entry of an order extending Staff’s deadline to January 29, 2024, to file comments and recommendations regarding the sufficiency of the application, the appropriate form of notice, if any, and the proper method for processing this docket.
