COMMISSION STAFF'S RESPONSE TO ORDER NO. 6 ON RECOMMENDATIONS

On December 8, 2023, Texas Energy Association for Marketers (TEAM) and Alliance for Retail Markets (ARM) (collectively, REP Coalition) filed a petition to have the Electric Reliability Council of Texas, Inc. (ERCOT) Contingency Reserve Service (ECRS) designated as an "ancillary service incurring a cost beyond a retail electric provider's (REP) control" under 16 Texas Administrative Code (TAC) § 25.475(b)(5).

On May 6, 2024, the administrative law judge (ALJ) filed Order No. 6, directing Commission Staff to file recommendations on sufficiency of notice and a proposed schedule, by May 15, 2024. Therefore, this pleading is timely filed.

I. RECOMMENDATION REGARDING SUFFICIENCY OF NOTICE

Notice in this proceeding is governed by the general notice requirements under 16 TAC § 22.55, which states that the presiding officer may require a party to provide reasonable notice to affected persons. The REP Coalition appealed parts of notice requirements in Order No. 4; and the Commission determined that notice here would be limited to ERCOT, the Office of Public Utility Counsel (OPUC), ERCOT's Retail Market Subcommittee and notice via Texas Register. The REP Coalition filed proof of notice on February 23, 2024. Thus, Commission Staff recommends that notice be found sufficient under the Commission's interim Order on Appeal.
