ERCOT'S REPORT ON DIRECT CURRENT TIE (DC TIE) ENERGY IMPORTS AND EXPORTS (APRIL 2025)

Electric Reliability Council of Texas, Inc. (ERCOT) submits this Report on DC Tie Energy Imports and Exports pursuant to 16 Tex. Admin. Code (TAC) § 25.192(e)(4), which requires ERCOT to file a public report containing certain information regarding energy imported and exported across DC Ties. Attached hereto as **Exhibit A**¹ is a spreadsheet containing the DC Tie information required by the rule.²

ERCOT welcomes input on this report and is available to provide any further information the Commission may need.

¹ The attached report does not include data for DC_EAST. According to Southwest Power Pool's website, https://opsportal.spp.org/DCTie/History/1, the "ERCOT EAST DC Tie in both directions will be limited to 0 as a result of an planned maintenance outage from 10/26/2024 to 6/13/2025."

² Note that on <u>Exhibit A</u> the Tab titled *QSE EXPORTS PAST 12 MONTHS* only lists a Qualified Scheduling Entity (QSE), and MWH exported for a given month if ERCOT's data reflected that the QSE scheduled energy exports over a DC Tie for that month.
